PEMBERITAHUAN KESELAMATAN SOSIAL PEKERJA

Nama dan permulaan kuat kuasa

1. (1) Pemberitahuan ini bolehlah dinamakan **Pemberitahuan Keselamatan Sosial Pekerja (Pengecualian Pekerja-Pekerja Asing) (Pembatalan) 2018**.

(2) Pemberitahuan ini mula berkuat kuasa pada 1 Januari 2019.

2. Pemberitahuan Keselamatan Sosial Pekerja (Pengecualian Pekerja-Pekerja Asing) 1993 [*P.U. (A) 56/1993*] dibatalkan.

Kecualian

3. Walaupun Pemberitahuan Keselamatan Sosial Pekerja (Pengecualian Pekerja-Pekerja Asing) 1993 dibatalkan, subperenggan (3)(b), (c) dan (d) Pemberitahuan yang dibatalkan itu hendaklah terus berkuat kuasa selepas berkuatkuasanya Pemberitahuan ini.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (EXEMPTION OF FOREIGN WORKERS)
(REVOCATION) NOTIFICATION 2018

IN exercise of the powers conferred by section 98 of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following notification:

Citation and commencement

1. (1) This notification may be cited as the **Employees' Social Security (Exemption of Foreign Workers) (Revocation) Notification 2018**.

(2) This Notification comes into operation on 1 January 2019.

Revocation

2. The Employees' Social Security (Exemption of Foreign Workers) Notification 1993 [P.U. (A) 56/1993] is revoked.

Saving

3. Notwithstanding the revocation of the Employees' Social Security (Exemption of Foreign Workers) Notification 1993, subparagraphs 3(b), (c) and (d) of the revoked Notification shall continue to remain in operation after the coming into operation of this Notification.
