AKTA KESELAMATAN SOSIAL PEKERJA 1969

PERINTAH KESELAMATAN SOSIAL PEKERJA (PINDAAN JADUAL PERTAMA) 2024

PADA menjalankan kuasa yang diberikan oleh subseksyen 3(4) Akta Keselamatan Sosial Pekerja 1969 [Akta 4], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Keselamatan Sosial Pekerja (Pindaan Jadual Pertama) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 Julai 2024.

Pindaan Jadual Pertama

2. Akta Keselamatan Sosial Pekerja 1969 dipinda dalam Jadual Pertama—

(a) dalam perenggan (12)—

(i) dalam subperenggan (ii), dengan menggantikan koma bernoktah di hujung perenggan itu dengan perkataan “; dan”;

(ii) dalam subperenggan (iii), dengan menggantikan perkataan “; dan” di hujung perenggan itu dengan noktah; dan

(iii) dengan memotong subperenggan (iv); dan

(b) dengan memasukkan selepas perenggan (12) perenggan yang berikut:

“(12A) Seseorang pekerja asing yang tidak mempunyai pas atau permit yang sah yang dikeluarkan oleh Ketua Pengarah Imigresen bagi maksud bekerja di Malaysia.”.

EMPLOYEES' SOCIAL SECURITY ACT 1969

EMPLOYEES' SOCIAL SECURITY (AMENDMENT OF FIRST SCHEDULE) ORDER 2024

IN exercise of the powers conferred by subsection 3(4) of the Employees' Social Security Act 1969 [Act 4], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Employees' Social Security (Amendment of First Schedule) Order 2024**.

(2) This Order comes into operation on 1 July 2024.

Amendment of First Schedule

2. The Employees' Social Security Act 1969 is amended in the First Schedule—

(a) in paragraph (12)—

(i) in subparagraph (ii), by substituting for the semicolon at the end of the paragraph the words “; and”;

(ii) in subparagraph (iii), by substituting for the words “; and” at the end of the paragraph a full stop; and

(iii) by deleting subparagraph (iv); and

(b) by inserting after paragraph (12) the following paragraph:

“(12A) A foreign worker who does not possess a valid pass or permit issued by the Director General of Immigration for the purpose of working in Malaysia.”.
